The CWD needs to be fully funded in two of the three accounts required by the USDA by the end of construction. This was explained in a letter sent by the office dated February 7, 2023

2. Claimed damage: A general discussion ensued between the Board members and concerned customers regarding preventions and suggestions of installed equipment.
